## LISTEN, RESPOND, ENHANCE


a message from Mayor Anderson

The one sure thing about living in a democratic republic is change. We participate in the process every two years, as we go to the polls to cast our vote. Campaigns are hard and grueling, but perhaps they should be. The candidates submit their platform to the marketplace of ideas. The citizens then vet those platforms. Sometimes the vetting process is comfortable and reassuring, as certain messages resonate with citizens. Sometimes the process is prickly and uncomfortable, as competing ideas and values collide with the candidate's platform. The hope is that through the process both the candidate and the citizens truly listen to each other, and that the best ideas emerge.

I hile campaigning, I heard a lot of competing ideas and thoughts. Some of these beliefs reaffirmed positions that I held. Others were quite different. But through it all, my eyes were opened to a variety of considerations and factors. In short, I was educated. I learned what issues matter to you, what concerns you have about our city, and what you hope will change and what you hope will not change. I kept a running list of the issues that matter to you. I intend to publish that list to the city council and to work on these issues over the next four years. Perhaps that is one of the more important fruits of a campaign—a list from the people, harvested through conversations on doorsteps, exchanges over email and social media, and countless phone conversations.

acknowledge that not every item on the list matters equally to each of you. That citizens of Farmington have different opinions on an issue should not displace the underlying fact that we are, first and foremost, citizens of Farmington, deserving of love and respect. I acknowledge an issue that stirs one person's passion, may equally stir another's disdain. That is the challenge of local government. Our collective success in this endeavor depends largely on our ability to listen and then work together for our common good. As we do so, may we be inclined to listen before we advocate. May we be quick to give the benefit of the doubt before we rush to condemnation. May we offer respect and kindness before we denigrate and demonize those whose opinions and beliefs differ from our own.

s we collectively start this journey, I Athank those who served before me (Mayor Talbot). I thank those who served with me (most recently, Rebecca Wayment and Shawn Beus). I thank those with whom I will serve going forward. I thank those who supported me in the campaign. I thank you for your support and trust. 
Historic preservation in the United States had its roots in the 19th century, according to a 1991 booklet produced by the National Trust for Historic Preservation. Originally focused on turning important properties into museums dedicated to the Founding Fathers, it evolved into cities taking an interest in preserving their local history to improve the quality of life in their communities.

Over the years, this attitude has been bolstered by the creation of tax incentives and grant programs in an effort to help business owners and homeowners renovate and restore their historic properties. Farmington residents whose properties may have historic significance could be eligible for help.

The Farmington Historic Preservation Commission, created in 1989, is responsible for assisting the city in identifying, preserving and enhancing buildings, sites, monuments, landmarks and streetscapes—such as

Main Street and State Street—that are deemed historically significant. The commission has helped create two National Historic Districts in Farmington. The Clark Lane Historic District, finalized in 1994, (www.clarklane.org) was the first National Historic District in Davis County. The Main Street Historic District was finalized in 2011(www.farmingtonmainstreet.org). Many homes in these districts may be eligible for financial incentives for preservation. But a property does not have to be in a historic district to qualify.

## WINTER FIRE SAFETY TIPS

a message from the Farmington Fire Department

More fires happen in the winter months than any other time of the year. Because we spend more time indoors and use different methods to heat our homes, it is important to keep fire safety in mind.

### IF YOU ARE USING A PORTABLE HEATER:

- Make sure the heater has an automatic shut-off so if it tips over, it shuts off.
- Keep anything that can burn such as bedding, clothing and curtains at least 3 feet from the heater.
- Plug portable heaters directly into wall outlets. Never use an extension cord or power strip.
- Turn heaters off when you go to bed or leave the room.

## IF YOU ARE USING A FIREPLACE:

- Keep a glass or metal screen in front of the fireplace to prevent embers or sparks from jumping out and starting a fire.
- Do not burn paper in your fireplace.
- Before you go to sleep or leave your home put the fire out completely.
- Put ashes in a metal container with a lid. Store the container outside at least 3 feet from your home.

#### IF YOU ARE USING A WOOD STOVE:

- Have your chimney inspected and cleaned each year by a professional.
- Keep anything that can burn at least 3 feet from the stove.
- Do not burn paper in your wood stove.
- Before you go to sleep or leave your home, put the fire out completely

When heating your home, you need to be aware of carbon monoxide. Carbon monoxide, also known as CO, is called the "invisible killer" because it's a colorless, odorless, and poisonous gas. More than 150 people in the U.S. die every year from accidental CO poisoning from generators or fuel-burning appliances such as furnaces, stoves, water heaters and fireplaces. Breathing CO at high levels can kill you.

Put CO alarms inside your home to provide an early warning of increasing CO levels. These alarms should be placed in a central location outside each sleeping area and on every level of your home. As always, make sure you have a smoke alarm on every level of your home, inside bedrooms and outside sleeping areas. Test your alarms every month. Have a home fire escape plan and practice your plan at least twice a year. Make sure everyone knows how to escape your home if there is a fire.

DeAnn Carlile was sworn in as Farmington City Recorder on December 7, 2021. The position is appointed by the mayor with the consent of the city council.

As city recorder, DeAnn will maintain and preserve the official records of the city and the proceedings of the city council. She will also maintain all city ordinances, resolutions, minutes adopted by the city council and the city municipal code. Additionally, DeAnn will serve as the Farmington Election Officer, responsible for administration of municipal elections.

# 2022 GARBAGE & RECYCLING COLLECTION SCHEDULE

When in doubt put it out!



The 2022 garbage and recycling collection calendar is now online at <u>farmington.utah.gov</u>. If you have forgotten whether your neighborhood is pink or blue, go to the <u>recycling map on the city website</u>.

The 2022 holiday schedule for collection service will be as follows:

**NEW YEARS**—no delay

MEMORIAL DAY—1 day delay

JULY 4th—1 day delay

**LABOR DAY**—1 day delay

**THANKSGIVING**—Thursday pickup on Friday, Friday pickup on Saturday

**CHRISTMAS**—no delay

**all other holidays**— *garbage pickup will remain on schedule* 

### Some rules to remember:

- Have cans at the curb by 6:00 am on collection day.
- Space cans 5 feet apart at the curb.
- Do not overfill cans. Lids should be closed. Request extra can if needed.
- No hazardous waste, appliances, hot coals or ashes, construction, remodeling or demolition debris allowed in garbage cans.
- Contact Robinson Waste Services at 801-825-3800 regarding garbage collection.
- If you need an extra can, complete a request on the city website, <u>farmington.utah.gov</u>.
- If you need a can repaired, replaced or removed, fill out a request on the <u>city website</u>.
