



## New CITY ROADS are DESIGNED for FUTURE GROWTH

Every two minutes a large dual dump truck exits I-15 through Farmington on route to some point along the West Davis Corridor (WDC). In addition to the WDC construction, UDOT is designing a new I-15 interchange at Shepard Lane. These are scheduled to be completed in 2024 and have created a need for the city to construct a road (950 North) to connect the two new interchanges. The city also needs a road network to connect these interchanges to Park Lane (see plan to the right). This road network is currently under design and is expected to be constructed in 2022-2024.

The future roads are designed for projected growth and are intended to alleviate heavy pass-through traffic currently occurring in residential areas. Without these new roads, neighborhoods would have to deal with the demand of future traffic, challenging existing infrastructure.

Funding for this new road system will not be borne by existing

## The FARM

The official ribbon cutting for The Farm was held Wednesday, September 8th. The Farm is a mountain bike trail network recently finalized in the foothills—8 trails, totaling 6 miles cut into 53 acres of land owned by Farmington City and the USFS. \$200,000+ was raised through donations and grants. Joint collection efforts by the Farmington High School mountain bike team, city leadership, and the Farmington Trails Committee were led by Jon Lowe. On a busy day, on-site trail counters have detected as many as 400 users on the trails during the hottest months of the summer, averaging 180 trail users daily. Thanks to the many partners who made this possible: IMBA, USFS, Phillips 66, Utah Office of Outdoor Recreation, Bikers Edge, FHS mountain bike team, REI, Jon Lowe, Shaun Speechly, Ben Butterfield, Tracy McCoy, Jon Hunter, Farmington Parks and Recreation, and Surface Trails. Farmington now has world-class mountain bike trails right in its own backyard.

City Roads continued

Farmington residents. New commercial and residential development will pay for a substantial portion over the next twenty years. Part of the funding came through the Utah Legislature via appropriations made in the 2019 legislative session. Some funding will come from the regional metropolitan planning office, Wasatch Front Regional Council. Some of the road construction costs will be paid by Station Park. The Davis County Council of Governments is funding 12 million dollars of the construction, which was the direct result of lobbying efforts made by Mayor Talbot, councilmembers, and county commissioners. By joining efforts, elected officials obtained funds for roads that will keep Farmington traffic running efficiently and safely.

- Main Street from 100 S to 500 N
- State Street from 400 W to 300 E
- 200 W from State to 200 S
- 400 N from Main to 100 E

The sweeper will be in these areas on a regular basis. Limbs and twigs cannot be picked up. Please do not put these types of materials at the curb. They plug the vacuum hose.

*If you do not live in the areas listed above, you are responsible to collect and dispose of the leaves on your property.* Please do not put your leaves in the street.

Elections are upcoming for Farmington City mayor and city council positions. The mayoral position is a four-year term—see candidate statements on page 6. **SHAWN J. BEUS**

Thank you for electing me two years ago to the city council. My emphasis remains: 1.) safety/trails-- we championed expanding the trails and upgrading street/trail crossings; supported our police, fire, and public works departments, and our most at-risk populations; 2.) history/charm-- reinvigorated the city's Historic Preservation Commission; 3.) housing-- formed a housing committee and an ordinance to provide lower priced housing options; 4.) transparency-- we should keep city meetings on Zoom.
