Minutes of the June 24th Farmington Historical Preservation Meeting.

In attendance were Shauna Wardrop, Dana Chapman, Melissa Layton, Darren DeGraw, Kathy Cornejo, Dorothy Arnold, David Petersen. David Barney attended by phone.

- Report of Chad Boshell, the City engineer about what the City is doing to help Clark Lane Historic District with traffic. State Street is considered a major collector, and thus it has different considerations when it comes to traffic mitigation. The City has put speed reminders up and will track traffic patterns for the next approximately six months.
 - a. The email regarding the exit from West Davis Highway at 1526 West was discussed. According to UDOT, this is currently on a very long-range plan. The City is making arguments to move it up on the priority list. At this point, the decision is made based on the density of homes in the area, and that is driving the perceived need. Reduction of traffic for State Street is not likely to move the needle. However emergency vehicle response could be a hook.
- 2. The Farmington Festival Days parade entry: Darren DeGraw is donating a trailer on which we will mount a banner, provided by Darren. We selected the best option for the banner. Dave Petersen will drive a truck pulling the trailer. The trailer will be parked at the Parks and Recreation building, where we will gather on Friday evening at 7:00 (weather permitting) and attach 14 20"x16" pictures of projects which will be visible to the parade-goers. Darren has provided zip ties, but we will need ladders and step stools. The banners and zip ties will be in David Petersen's office by July 10th. The rear of the trailer will feature a large photo encouraging people to visit our booth for Festival Days. With inclement weather, we will attach the photos, etc. at 7:00 A.M. from our spot in the parade line-up.
- 3. Status of MPS nominations: Cory Jensen has indicated that all six nominations will be on the agenda for the January 2025 review. We are still working on some edits for the nominations, which should be done in the next 2-3 weeks.
- 4. Nomination of the Main Street Historic District to the Farmington Landmarks Register. This is done, as per David Petersen.
- 5. The Commission was given samples of the fliers Kathy Cornejo has been working on and these will be mailed out to eligible candidate homes. We will have some fliers in the booth.
- 6. CSBS is beginning its evaluation of the property. We need to hustle on this.
- 7. May HPC minutes were approved.
