James Wilcox Home / Carrie Fastwaters speaking on behalf of the Wilcox family on Zoom call.

- a. Request from David Barney, Chair of the FCHPC, to designate the James Wilcox home at 1149 S 200 E as a historic resource on the Farmington city Historic Landmark Register pursuant to Ch 39 of the Zoning Ordinance.
- b. We went through Section 11-39-050 E, The Wilcox home meets 5 (A through E) of the 7 criteria that are necessary for the Landmark Register Designation. Only two of the seven criteria are required.
- c. So, motioned and second all in Favor. Then forward to the city hear back around June 17th

2. Sorrel Springs – Historic home at 638 N Compton Road

a. Evans Home will be saved, moving the road around will allow the 10 lots and keeping the historic home.

1. James H. Wilcox Home Landmarks Register Designation:

a. The James H. Wilcox home was approved by the Farmington City Council to be added to the Landmarks Register in early June. The main part of the home housed Farmington's first Mayor and is in good shape inside and out to this day. The Commission was concerned the new owner/developer of surrounding land would tear down the home, however; the Landmarks register will protect the home. In addition, there were discussions to potentially add a conservation to the home.

2. Festival Days – getting organized:

- a. Parade entry Float: Put together on July 11th at 6PM. Dave, Dana, Elise & Dave's children will help.
- b. Booth: Vendor set up at noon on July 12th. Elise, David, Dana and Dorothy will set up and stay until 4 pm.
- c. Home Tours July 10th through the 12th. Signs made for yard with QR code about the tour/homes to be used on phones. DJ Blood wants to be on the tour. Most homes from the 1800's are on the National Register.
- d. All are welcome to breakfast in the park, beginning at 8 am on Saturday the 12th.

DETERIORATION BY NEGLECT Status of home 368 West State Street:

a. Andrew Clark has no change. The City is going a different route on this property because someone is living there at the moment; there are certain rules they have to go by with someone living there and not complying. Eric Miller, the City Building Official, is handing this.

4. DETERIORATION BY NEGLECT Historic Barn at 268 West State:

a. There are currently no more grants this year – everything is on pause. We are waiting for the National Park Services to give the go-ahead. A suggestion to consult with Lagoon for funds was made.

5. Farmington Historic Plague Program:

a. The Barton home from 1890 is looking at businesses that are in historic homes for Historic Plaque Program, as well as the homes that Lagoon owns.

6. Butter Bake Shop / Restaurant in the historic 1877 Rose Cottage:

a. Hannah Hall owns the property right now, she is still waiting for a \$50,000 grant. The garden was moved to a larger space as the city is selling land that is around the home. The money from the land will be used for the new west-side fire station.

7. Neal Sessions / Francisco Restaurant:

a. Currently, we are looking for the right mortar to put it back up. The Insurance business has moved to different location.
