WINTER FIRE SAFETY TIPS

More fires happen in the winter months than any other time of the year. Because we spend more time indoors and use different methods to heat our homes, it is important to keep fire safety in mind.

IF YOU ARE USING A PORTABLE HEATER

- Make sure the heater has an automatic shut-off so if it tips over, it shuts off.
- Keep flammables such as bedding, clothing and curtains at least 3 feet from the heater.
- Plug portable heaters directly into wall outlets.
 Never use an extension cord or power strip.
- Turn heaters off when you go to bed or leave the room.

IF YOU ARE USING A FIREPLACE

- Keep a glass or metal screen in front of the fireplace to prevent embers or sparks from jumping out and starting a fire.
- Do not burn paper in your fireplace.
- Before you go to sleep or leave your home put the fire out completely.
- Put ashes in a metal container with a lid. Store the container outside at least 3 feet from your home.

IF YOU ARE USING A WOOD STOVE

Have your chimney inspected and cleaned by a professional each year. Keep anything that can burn at least 3 feet from the stove.

■ Do not burn paper in your wood stove.

Before you go to sleep or leave your home, put the fire out completely.

When heating your home, be aware of carbon monoxide, also known as CO or the "invisible killer" because it's a colorless, odorless, and poisonous gas. More than 150 people in the U.S. die every year from accidental CO poisoning from generators or fuel-burning appliances such as furnaces, stoves, water heaters and fireplaces. Breathing CO at high levels can kill you. CO alarms provide an early warning of increasing CO levels and should be placed in a central location outside each sleeping area and on every level of your home.

Additionally, make sure you have a smoke alarm on every level of your home, inside bedrooms and outside sleeping areas. Test your alarms every month. Have a home fire escape plan and practice your plan at least twice a year. Everyone in your home should know how to escape if there is a fire.

Commercial, mobile, and in-home daycare/ preschool business licenses expire each year on December 31 and must be renewed annually. Renewal notices are sent through Civic Review to the email address on file approximately 45 days before expiration (on or around November 16). Please ensure your contact information—especially your email—is up to date, and that Civic Review emails are not blocked by your spam filter. Paper notices are not mailed. To verify or update your email, call us at the number below.

Once your renewal is approved, you will receive instructions to submit payment. Only after payment is received can you print your renewed license at your convenience.

As leaves continue to fall, remember

that you are responsible to collect and dispose of the leaves on your property.

ONLY leaves from the street

ONLY leaves from the street trees along State and Main streets are eligible for city pickup. All other homes and all other fallen leaves are the responsibility of the homeowner. PLEASE DO NOT blow these leaves into the street or park strip. Instead, bag and throw away leaves or take them to the landfill.

FOR THOSE WHO LIVE ALONG STATE & MAIN STREETS:

Main Street from 100 S to 500 N State Street from 400 W to 300 E 200 W from State to 200 S 400 N from Main to 100 E

The city sweeper will come by on a regular basis, 1–2 times per week, from October through December. Please only put leaves out, as limbs and twigs cannot be picked up and will clog the hose.

Please note: simply submitting renewal information is not the same as completing your renewal. Complete your renewal and payment by 12/31/25 to avoid late fees.

Helpful Tip: Before renewing, confirm that your business name and/or DBA is listed as "active" on the Utah Business Registration site and that your TAP number is valid for Farmington City, if you collect sales tax. We do check and verify this information during renewal. If it shows as not active or does not show Farmington City as your TAP location, it will delay your renewal.



FARMINGTON'S TREE-LINED **STREETS** PROGRAM

I love meeting new people. Upon introduction, my favorite subject is, of course, Farmington City. Young people love talking about Lagoon. As the audience gets older, they become curious about Station Park and what is happening there. But a seasoned Farmington connoisseur is full of praise for the beautiful trees on State Street and Main.

A Chinese saying is, "the best time to plant a tree was 20 years ago." We are indeed the beneficiaries of the wisdom of tree plantings 100 years ago. This appreciation and philosophy are the basis for beginning the Tree-Lined Streets Program.

The Tree-Lined Streets Program was first funded in 2017 by the mayor and the city council and has continued to this day. Through this program, residents receive a 50% discount on a tree and its installation along the street right-of-way. In the initial years, residents planted the trees themselves with varying degrees of success. A wise landscape architect once told me, "One should plant a \$1 tree in a \$2 hole." The program has evolved through the years. The forestry staff at the city reviews options of trees that would thrive in a certain location and then hires an arborist landscaper to do the "hole prep" and installation, giving the trees the best chance of survival and growth.

Since the program was started, there have been over 500 trees planted along Farmington streets and sidewalks. This partnership takes advantage of economies of scale through bulk tree pricing. Of course, it would not be possible without the city staff and the residents working together to make it a success. After the tree is planted, the city is out of the picture; the maintenance and care for the tree is the responsibility of the residents.

If you are interested in participating in the tree-lined streets program, more details can be found on the city website. As Main Street clearly illustrates, the trees are a legacy to be celebrated long after our stewardship of this community is passed on to the next generation.
